News and Information for Region 7 AEG Members From Phyllis Steckel, RG; AEG Region 7 Director

On April 30 and May 1, the AEG Board of Directors met in Kansas City, Mo. This is the “Mid-Year Board Meeting” (MYBM – a tricky acronym that usually reminds me to “mind your own business). The main agenda of this meeting is to address and move forward with business of AEG. Key topics included:

- The AEG Board discussed the need for **each AEG chapter to have a succession plan**. Many AEG chapters are voting on new officers around this time. While new officers will bring a new approach to the chapters’ activities, it is a good time to identify those who may want to be included in a succession plan. Chapters may have a one-year or two-year term for their officers, which usually comes around quicker than anyone thought possible. So, if anyone is interested in helping their chapter, please make yourself known to the current officers.
- We heard an interesting approach to chapter meetings that was presented by the AEG Las Vegas Chapter: they have an active, but modest, treasury that they actually *use regularly* instead of letting it ‘sit and grow.’ Their meeting planner will **bring in well-known speakers from all over the country**, put them in a hotel for a night or two, take them to dinner, and show them around a bit. Their regular chapter meetings often have 50 to 60 attendees. Same with field trips, which are hosted at least once or twice a year in Las Vegas. Sponsors are lined up to support such events. If your chapter’s speakers’ roster needs to be perked up, do it! Chapter treasuries may not need much more than two or three thousand in them. Think about your chapters’ real needs – then plan to energize your roster of meeting speakers.
- AEG has a Calendar of Events of its website (www.aegweb.org and log-in first). Please **add your chapters’ events, such as meetings, field trips, workshops, etc. to the AEG Calendar of Events**, especially if the event is virtual or hybrid (in person and virtual). By advertising the virtual option, you may attract distant members who are interested in the topic.
- AEG also has a “**Chapter Toolkit**” that should be your first stop for questions and information about your chapter leadership and management. It is also on the AEG website (www.aegweb.org and log-in first).
- AEG offers a **monthly Zoom event hosted by the Chapter Support Committee**. This is regularly scheduled for **11:30 am (Central Time) on the third Friday** of most months. Email Sheri Maskow (manager@aegweb.org) to get regular email reminders and links for these Zoom events. Topics

include upcoming deadlines for scholarships, grants, annual reports, etc.; at-large AEG events; professional registration news; and more. If you have questions about somethings, this might be an easy way to get an answer.

- Each AEG chapter should have **full contact information for Chapter officers** on file with the AEG Manager, Sheri Maskow (manager@aegweb.org). Please make sure your new chapter officers have provided this to Sheri as soon as possible.

- Chapter Treasurers must share their chapter's monthly treasury account balance with the AEG manager. Contact Sheri Maskow for more information (manager@aegweb.org). This is simply an accounting requirement for the Association.
- The legal address of AEG has been in California since the early 1960s. However, the legal requirements needed to manage AEG as a "California Association" have become burdensome and expensive – a California-licensed attorney is often needed for the Association's day-to-day business. As a result, **the AEG Board has voted to move the legal address and business operations of AEG from California to the State of Ohio**, which is much easier and simpler – and usually does not require the assistance of an attorney. Also, the AEG Business Manager, J&M Business Solutions, is located in Brunswick, Ohio. AEG's main point-of-contact with J&M is Sheri Maskow, company owner and general manager. This is for AEG only; the AEG Foundation is still located in California.
